### Linda Lawson

State Representative Linda Lawson, our luncheon speaker, has been a long-time member of the Hammond community. She attended Indiana University Northwest. She was the first female police officer for the Hammond Police Department and retired as a captain after 24 years.

In 1998, Lawson was elected to

the Indiana House of Representatives for District 1. She has chaired the House Judiciary Committee and served on the Environmental Affairs, Family Affairs, Education, Labor and Indiana House Courts & Criminal Code Committee, and is currently Indiana House Democratic Floor Leader.

Representative Lawson has been involved in many pieces of domestic violence legislation. She has served on numerous boards such as Haven House (women's shelter), the Hammond Historical Society, the Robertsdale/Whiting Chamber of Commerce, and the League of Women Voters.



#### Judy M. Zell, CPA

Judy Zell will present Workshop 1A on Lean In and will co-present the Presidents/ Treasurers Workshop with Pat Barker. Judy graduated from Indiana University and studied accounting at Butler University. After working for Bailey, Cord, and Williams, she started her own accounting practice in the summer of 1979. # Celebrating Women: Legislative Achievements

### INFBPW Legislative Accomplishments

The Indiana Federation of Business and Professional Women was founded on July 16, 1919, 95 years ago. The 19th amendment had just passed Congress in June 1919, and the battle was on for ratification. Indiana became the 26th state to ratify this crucial amendment, on January 16, 1920.

A continuing thread through all of INFBPW's legislative accomplishments has been the campaign for the Equal Rights Amendment (ERA) to the US Constitution:

#### The Alice Paul Equal Rights Amendment

Equality of rights under the law shall not be denied or abridged by the United States or by any state on account of sex.

INFBPW was among the first women's organizations to endorse the Equal Rights Amendment in 1937. Additionally, INFBPW has been a leader in passing key legislation affecting working women including:

**Equal Pay Act** (1963) – Requires that men and women be given equal pay for equal work in the same establishment.

**The Civil Rights Act** (1964) – Landmark legislation that outlawed segregation in schools, public places, and employment. The bill was amended prior to passage to protect women. It also created the Equal Employment Opportunity Commission.

**Title IX of the Education Amendments** (1972) – Federal statute which prohibits sex discrimination in education programs and activities that receive federal financial assistance.

The Women's Business Ownership Act (1988) – Establishes programs and initiates efforts to assist development of small businesses owned and controlled by women entrepreneurs. Established the National Women's Business Council and provides for collection of statistics.

**The Family & Medical Leave Act** (1993) – Provides employees of businesses with 50 or more staff members, with up to 12 weeks per year of unpaid leave following childbirth or adoption; to care for a child, parent or spouse with a serious health condition; or to address the employee's own serious health condition.

**Violence Against Women Act** (1994) – Enhances safety for women and children by funding life-saving services, prevention and community programs, and funding law enforcement and judicial systems to prosecute abusers.

The Civil Rights Tax Relief Act (2004) – Allows individuals who settle or win employment discrimination cases to deduct the fees and costs paid to attorneys.

The Debbie Smith Act (2004) – Authorizes over a billion dollars to process a backlog of DNA evidence; to improve collection and processing by establishing a national standard for gathering DNA evidence; and to train sexual-assault forensic examiners, prosecutors, and law enforcement officers in collecting and using DNA evidence.

**Johanna's Law** (2005) – Authorizes a national gynecologic cancer early detection and awareness campaign targeted for women and their healthcare providers.

Lilly Ledbetter Fair Pay Act of 2009 – Reverses the Supreme Court's 5-4 ruling in 2007 (Ledbetter v. Goodyear Tire and Rubber Co.) and restores the ability of victims of wage discrimination to hold their employers accountable for injustice and challenge the practice in court.



### District 2 Report

Although the Bell's Palsy has gone away, I still have hearing loss in my left ear. This makes me dizzy--or is that dizzier? Anyway, it prohibited my attendance at the State Convention, and I feel lost because of it. Finally, I am able to drive out-of-town, but some days are better than others.

I do intend to visit all of the clubs in District 2 this fall. We previously had only two clubs in District 7, but now there are several clubs in the new District 2. I hope I can find everyone.

Most of our clubs have organized Reality Store<sup>®</sup> programs, raised funds for various causes, and presented scholarships. District 2 stays very busy. Our District 2 Fall Meeting will be on November 15th at Sugarbaker's in Knightstown.

The Foundation currently has seven (7) named funds which INFBPW members, local organizations, foundations, individuals and groups support through contributions and fundraisers.

The Foundation is governed by a sevenmember Board of Trustees, who serve three-year terms. The president and president-elect of INFBPW serve as trustees by virtue of their office. Liaison members of the Foundation include the INFBPW State Foundation chair, INFBPW Choices chair, Director of Marketing, Director of The Reality Store<sup>®</sup>, and Director of Development.


