

District 2 will be meeting March 9 at Sugarbakers in Knightstown, and District 3 will be meeting in Terre Haute at The Landing.

When we come together for State Convention in April, we will be ready to begin a new year. Thank you to all for your support in this redistricting project. I'm looking forward to seeing you at your Spring Meetings.

INFBPW/Merrillville-Duneland News

On December 2, 2012, INFBPW/Merrillville-Duneland held a successful brunch to benefit the Lake County Transitional Court Program. The cost to attend was \$15 for brunch and a \$10 shower gift.

The event provided assistance to those trying to get their lives back on track, with guidance from the Lake County Transitional Court Program. Making the transition from a prison environment to civilian life is not easy. Clothing, personal hygiene items, household products, non-perishable food items, and gift cards were presented as shower gifts to help these individuals prepare for jobs and set up a household. Helping them realize that they are not alone and that people do care about them will make it easier to make a fresh start.

The Lake County Community Transition Court is a program to help individuals transition from the Indiana Department of Correction (Michigan City, Westville, etc.) back to their community, while still being supervised. The goal is to help these individuals re-engage as productive citizens. Participants are supervised by case managers for the entire transition, from eight to twelve months. The case managers, along with the Community Transition Court team, assist participants with life skills, identification, referrals for mental or substance abuse treatment, and other necessary classes and skills.

Participants take part in three levels of the Community Transition Court Program –

Phase 1 (90-120 days)—Participants reside at the work release center or at home with electronic monitoring and attend weekly court hearings.

Phase 2 (60-90 days)—Participants reside at home with electric monitoring. They attend court hearings every other week.

Phase 3 (30-60 days)—Participants reside at home without electronic monitoring and attend court hearings once per month.
