Judy O'Bannon, Luncheon Speaker

Judy O'Bannon has spent much of her life supporting and promoting efforts to strengthen communities in Indiana and around the world. She actively speaks and writes on issues facing society today and leads humanitarian missions abroad.

As host and producer of the WFYI-TV public television series *Communities Building Community*, Judy brings attention to the ways Hoosiers foster community life in Indiana. The series has won three Emmy awards for public affairs programming. Her new television series, *Judy O'Bannon's Foreign Exchange*, looks at the commonality of community dynamics around the world.

As First Lady of Indiana (1997-2003), Judy used her role to promote civic engagement. She created and led the Hoosier Millennium and Indiana 2016 initiatives with nearly 200 participating communities. Seeing the Governor's Residence as the "State's living room," she made the Residence a gathering place for Hoosiers to share ideas and talents, celebrate achievements, and plan for the future.

As chair of the Indiana Main Street Council, she emphasized the revitalization of downtown districts through community development and historic preservation. She served on the Community Revitalization Committee, as a trustee of the National Trust for Historic Preservation and on the Executive Board of Directors of the Historic Landmarks Foundation of Indiana. She is a trustee of the Indiana State Museum. Judy co-founded Partners in Politics, a support and information group for family members of public officeholders.

Judy is chairman of The O'Bannon Publishing Company, which publishes the award winning Corydon Democrat and Clarion newspapers.

In 1985, after her husband's kidney transplant, she started college at IUS, taking biology and chemistry. She enjoyed viewing things under a microscope; so after graduation, she worked in a hospital lab for 19 years.

After her husband's death in 1998, Norma looked into natural healing. She found a radio program hosted by Dr. Joel Wallach, founder of Youngevity, a health and wellness company. She is now an independent distributor of Youngevity products. *Norma will present an overview of selected essential oils and how to use them.*
