JENNIE SCOTT AWARD

This award has been established to recognize an INFBPW member who has made the greatest contribution toward the objectives of our Federation in her own local organization and in INFBPW during the year of competition.

PURPOSE

The purpose of the award is to encourage and promote Indiana members to be involved at all levels of INFBPW, including leadership responsibilities as well as attendance and participation at local, district, state meetings.

AWARD

A certificate of recognition and monetary award of \$25.00 will be presented to the recipient at the Fall Conference.

QUALIFICATIONS

Nominees must have been a member of a local organization in good standing for at least five (5) consecutive years. She must have a record of at least 80% attendance at local organization meetings and have sponsored at least one (1) new member during the period of competition. She must be an active participant in her local organization's activities. Although emphasis will be placed on current activities, a nominee's INFBPW background of past activities, honors, and accomplishments will be taken into consideration in making the selection. The biographical sketch of all nominees shall include their past club history and district activities in respect to offices held. Nominees must not currently be a member of the INFBPW Executive Committee. The same person may be a nominee more than once but can only receive the award one time.

PERIOD

The period of competition shall be from June 1, to May 31.

NOMINATION

Nominations for this award shall originate from a local organization in good standing. Nominations shall have the approval of the executive committee of the recipient's local organization. Only one nominee from each local organization will be permitted, and all nominations must be submitted in the prescribed form.

SUBMISSION

Nominations on the prescribed form must be submitted to the State Office on or before September 15. Mail to address indicated on application.

SELECTION

The State President Elect shall consider all nominations received and shall recommend not more than six (6) or less than three (3) names to the awards committee for further consideration and final selection. The names of the nominees not receiving the award shall not be made public. Selections shall be based upon a point system—50 points on attendance criteria and 50 points for the biographical sketch and information contained on the nominee form.
