Mary Hobbs is the mastermind behind BeeHive Body Co. With over a decade of experience, this all began with a batch of soap. With a culinary background in mass production catering and numerous lessons learned from my service in the United States Air Force as a fighter jet mechanic, I became a passionate business owner. At BeeHive, our staff works hard to craft products that clean, relax, and unwind, offering an experience that keeps you coming back for more. We take pride in our craft, and it is reflected in the quality and experience our products give you. Passionately, in-house crafted bath and skin care products are suited for everyone in your family!

Over the years, we have grown and evolved into a substantial production facility, starting from humble beginnings in a basement in Utah. We span the state of Indiana through retail contracts and wholesale accounts. In September, we hit the road and vend at six shows over five weekends, spanning 200 miles. Our private label business is expanding daily; we make over 5,000 custom lip balms that companies use for marketing materials. We love working with other businesses, creating custom products that their customers love.

In May of 2024, we signed a lease that moved us into a 4,500-square-foot historic building in downtown New Castle. This building has allowed us to grow substantially while also providing a space for a classroom. The addition of a classroom has been a great way to let the community's creativity flow, and kids have a fun lesson in chemistry and creativity.

Legislative Updates...

We have several bills coming up that may affect us as women in Indiana.

Federal:

The Big Beautiful bill that is trying to be passed will negatively affect Medicaid: according to the Indiana senate website:

The bill cuts Medicaid by more than \$1 trillion nationwide, according to the Congressional Budget Office. In Indiana, 2.3 million people rely on Medicaid, including children, seniors and low-income workers. New work and paperwork requirements are expected to knock tens of thousands of Hoosiers off the rolls.

Indiana:

Education bill that pulled state funding for Pre-K classes in the public schools.

State bill 191- Doctors have to report to the state and federal government every termination of pregnancy, miscarriage, legal abortion to save the mother's life, etc.... The doctor can lose his licenses and the woman can be charged for termination of the pregnancy. This violates HIPPA laws that are now in effect that protect women from personal information getting shared.

These are some of the bills that we need to keep track of and talk to you congressmen and senators.
